If the employer or some officer of the employer makes a false statement or representation or withholds any wage or salary

check from an employee with the intent to injure the employee's financial condition, or with reckless disregard as to the truth of the statement or representation made or of the withholding of the wage or salary check from the employee, or when in the exercise of good faith a wage check is withheld from an employee, the employer shall be guilty of a misdemeanor. Any employer who in the absence of a valid basis for withholding the wage check of an employee and without the consent of the employee wilfully fails to pay wages due such employee at the

regular payday for the pay period during which the employee's termination took place or from the time wages are due to the time the claim is presented for payment, or any employee who wilfully fails to cooperate with any employer in the wage claims procedures provided by this act, shall be guilty of a misdemeanor and, upon conviction thereof, be punished by a fine of not less than fifty dollars (\$50.00) nor more than two hundred dollars (\$200.00), or by imprisonment for not less than ten days nor more than ninety days, or by both fine and imprisonment. Any employer

who wilfully fails to pay any wages due or claims against his or her estate or credits held by any persons on their behalf may be ordered to pay such wages or to account for and pay the amounts due and owing to each person. Any person who wilfully fails to pay wages due to any employee, or to pay wages and obtain employment for any employee, when directed by his or her employer or by the commissioner, or when requested by the employee, or when ordered by the commissioner pursuant to section 5 of this act, or who makes any statement or

representation or withholds any wage check with the intent to injure the financial condition or to injure the credit of an employee or to mislead such employee, or when in the exercise of good faith a wage check is withheld from an employee by any officer or manager of an establishment or by any other person, or when in the exercise of good faith a wage check is withheld from an employee by any person, officer, or manager of an establishment, shall be guilty of a misdemeanor and, upon conviction, be punished by a fine of not less than fifty dollars (\$50.00), nor

more than two hundred dollars (\$200.00), or by imprisonment for not less than ten days nor more than ninety days, or by both fine and imprisonment. If the employee's request to his employer for the wage is for \$10 or less, the employee may forfeit any right to penalties and sanctions under this act. The provisions of this paragraph relating to payment of wages, withholding wage checks and failure to cooperate or wilful failure to pay wages shall not be applicable to the loss of pay or wages resulting from death, hospitalization or total incapacity
