(3) Notwithstanding the scope of section 631,
subdivision (c), a trial court may exercise discretion and
fashion a remedy which grants reasonable visitation to a

Cal.App.3d at p. 823.) (4) The detriment to a child from
visitation between a noncustodial parent and his or her
child may not be equated with a detriment to a child
from the denial of visitation. (In re Marriage of Neal,
supra, 95 Cal.App.3d at p. 824.) The visitation between a
noncustodial parent and his or her child should not be
permitted unless the court concludes that it is in the
best interests of the child. In exercising its discretion to
enter an order of visitation, the trial court considers
such factors as the child's special needs, the effect of

exposure to the noncustodial parent's side of the family, and the adverse consequences of visitation on the child's social life. (Id. at pp. 824-825.) C. Review of Trial Court Rulings (5) Our review of the parties' appellate briefs and the appellate record leads us to the following conclusions concerning the trial court's rulings at the December 18 hearing: (1) In ordering visitation in the custody proceedings, the court properly deferred to the judgment of parents on such matters.
